Without spending a lot of time on statistics, I'll presume all present are aware closer proximity increases the chance of person to person Covid 19 spread.

This testimony goes low on data and high on broader questions and possible solutions for Super Spreader conditions faced by the unhoused in Massachusetts for Winter 2021:

Intro:

1 out of every 350 people in Massachusetts is "Unhoused". [1][2]

Unhoused persons, especially those at emergency shelters are considered extremely high risk for the contraction and spread of Covid 19. Also, death numbers from Covid 19 of the unhoused are staggering relative to the general population.

Mitigation:

OSF Healthcare - July 2020

Superspreaders: "These factors affect how fast COVID-19 can spread" [4] "If you have a person who has a high viral load ... land1 that person is shouting in a location that has very little ventilation, there is a higher risk of exposure to contagious droplets to the people around them."...

It may not be possible to describe the environment in a Homeless Shelter more accurately than that.... Close proximity, loud, with people talking over each other, shouting matches and sometimes physical altercations.

Ventilation is usually poor.. It's also a highly common practice for shelter guests to smoke from the same cigarette or drink from the same beverage container.

For those unhoused choosing against the oppressive conditions of the shelter system, many will double up in small enclosures or even the same sleeping bag.

Homeless Calculations: Massachusetts (rounded)

7,000,000 - Massachusetts Population

divided by

<u>20,000</u> - Unhoused

350 persons - 1 out of every 350 citizens = unhoused

[1] As of January 2019, Massachusetts had an estimated 18,471 experiencing homelessness on any given day, as reported by Continuums of Care to the U.S. Department of Housing and Urban Development (HUD). Of that Total, 3,766 were family households, 917 were Veterans, 480 were unaccompanied young adults (aged 18-24), and 2,370 were individuals experiencing chronic homelessness.
